1. "ROAMING **life:)**" is a special offer for **life:)** subscribers who use international roaming services in Bulgaria, Germany, Latvia, Lithuania, Poland, Russia, Romania, Turkey, Ukraine, Czech Republic and Croatia .
2. Terms and conditions of "ROAMING **life:)**" special offer: discounted tariffs are applied to international roaming services used in "**Globul**" network of "Cosmo Bulgaria Mobile EAD" operator (Bulgaria), "**T-Mobile**" network of "Telekom Deutschland GmbH" operator (Germany), "**Tele2**" network of "Tele2 Latvia" operator (Latvia), "**Tele2**" network of "UAB Tele2" operator (Lithuania), "**Orange**" network of "PTK Centertel Sp. z o.o." operator (Poland), "**MegaFon**" network of "OJSC MegaFon" operator (Russia), "**Cosmote**" network of " Cosmote Romanian Mobile Telecommunications S.A." operator (Romania), "**Turkcell**" network of "Turkcell Iletisim Hizmetleri A.S." operator (Turkey), "**life:)**" network of "Astelit LLC" operator (Ukraine), operator «**T-Mobile**» network of «T-Mobile Czech Republic a.s.» (Czech Republic) and operator «**Tele2**» network «Tele2 d.o.o Croatia» (Croatia):

3. "ROAMING **life:)**" special offer covers all **life:)** subscribers (private persons, legal entities, individual entrepreneurs), both prepaid and postpaid.
4. All tariffs within "ROAMING **life:)**" special offer are per minute charging based.
5. For each calendar day during which the subscriber made or received voice calls in networks of roaming partners listed in article 2 a fee of 2 299 Br (excluding VAT, not applicable to individual persons) is charged.
6. For prepaid subscribers the amount stated in article 5 is debited from main account after expiration of a calendar day according to time zone where Republic of Belarus is situated. In case of a negative balance after debiting the amount stated in article 5 service provisioning is stopped unless the debt is discharged.

7. For postpaid corporate customers the amount stated in article 5 is included in a bill for services. The fee indicated in article 5 is applied upon receipt of information about roaming services used by postpaid corporate customers from roaming partners. Final amount of payments stated in article 5 can be applied in some time after voice services within "ROAMING **life:)**" special offer have been actually used.
8. For types of services not listed in article 2 as well as for services used in networks of roaming partners not indicated in article 2, "ROAMING **life:)**" special offer is not applicable.
